Membership fees comprise up to 3 amounts; a **Club Membership**, **Timing Transponder** and a **BikeNZ licence**. There are different Bike NZ licences depending on the level of competition you intend to participate in. Every rider must have **both a club membership and BikeNZ licence**.

RAMBLERS CLUB MEMBERSHIP FEE: Ramblers club subs are unchanged, as follows

Under 17 (as at 31/12/10) \$15

Under 19 and a full time student \$15

Non riders \$15

All others \$35

Note: Family discount of \$15.00 applies to third family member in a calendar year, that member being a school student, with a minimum of one family discount per year.

TRANSPONDERS FOR 2010:

Ramblers Cycling Club has electronic transponders to record race results. Only riders with current transponders will have their placing recorded, if you are a new member you will need to purchase one. The cost per unit is \$10 and can only be used in Ramblers weekly club races. **No transponder, no placing.**

BIKENZ LICENCE CATEGORIES:

1. CLUB LICENCE - Cost \$25

This licence can only be used for racing our normal club races. If you wish to race outside our club you must have either a Centre or Nationals Licence

2. CENTRE LICENCE - Cost \$40

This licence is available for racing at ours organised events and other clubs in our Centre including opens and interclub. To date the other clubs in the Centre are CHB Cycling and Gisborne. A Centre licence is required if you participate in a Centre event which to date is are the ECNI champs, The Hub 2 Day Tour, The CHB Junior Tour and Taupo to Napier.

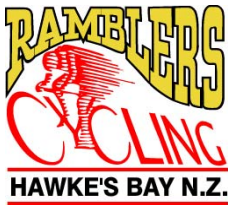
3. NATIONAL LICENCE - Cost \$80 (Under 17 \$25)

These licenses can be used in most Road, Track, and Mountain Bike Club, Centre and National Events, including National Championships and Open events run by an affiliated Club or Centre, or sanctioned by BR&T/MTBNZ or BikeNZ.

4. INTERNATIONAL LICENCE – Cost \$130 + Insurance. Contact club for further details.

DECLARATION

I, the person who has applied to BikeNZ and either BR&T or MTBNZ (my Member Organisation) for a Licence:

1. Declare that:
 - (a) I am not aware of any reason why I should not be issued with the licence requested;
 - (b) I have not applied for a licence for the same year to the International Cycling Union (UCI) or to any other national cycling federation;
 - (c) I assume exclusive liability for this application and for the use I will make of the licence.
2. Undertake to:
 - (a) return my licence immediately in the event of any substantial change to the circumstances existing at the time of this application;
 - (b) comply with the constitutions, regulations, policies, manuals, guidelines and reasonable directions of BikeNZ, my Member Organisation and the UCI ;
 - (c) participate in cycling competitions and events in a fair and sporting manner;
 - (d) submit to disciplinary measures taken against me by BikeNZ, my Member Organisation or the UCI and take any appeals and litigation before the authorities provided for in the Constitution or Regulations of BikeNZ, my Member Organisation or the UCI;
 - (e) accept the Judicial Panels established by BikeNZ and my Member Organisation , the New Zealand Sports Disputes Tribunal and the Court of Arbitration for Sport (CAS) as the only competent jurisdictions in cases provided for by the Regulations of BikeNZ, my and UCI and that, in the case of CAS, its decisions will be final and binding and not subject to further appeal;
 - (f) subject to paragraph (e), submit any litigation with the UCI exclusively to the tribunals at UCI headquarters.
3. Undertake to comply with the Anti-Doping Policies of BikeNZ and my Member Organisation , the UCI Anti-Doping Regulations, the clauses of the World Anti-Doping Code and its International Standards to which the UCI Anti-Doping Regulations refer, as well as the anti-doping regulations of other competent bodies as per the UCI Anti-Doping Regulations and the World Anti-Doping Code, provided that those regulations comply with the World Anti-Doping Code. I accordingly acknowledge and accept:
 - (a) that all urine samples taken will become the property of the UCI, which may have them analysed, especially for purposes of health protection research and information;
 - (b) that the results of any analysis may be made public and communicated in detail to my club or team or to my paramedical assistant or doctor;
 - (c) that my doctor or the doctor of my club or team may, on request from the UCI, communicate to the UCI a list of any medicines I took and treatment I underwent before any given competition;
 - (d) the conditions regarding blood testing and agree to undergo blood tests.
4. Consent to the collection, use and retention of the information in this application by BikeNZ and my Member Organisation for the purpose of maintaining membership records and for them to disclose that information to UCI, SPARC, NZOC, Drug Free New Zealand any other competent body recognised by the UCI, sponsors, funding agencies, kindred organisations and the media.
5. The details set out in the Application for Membership Form are true and correct. If they change I acknowledge that I am required to notify BikeNZ of the changes, in writing, as soon as possible after they occur.
6. I understand that BikeNZ and my Member Organisation will collect, hold, use and disclose personal information about me for the purposes of:
 - (a) enabling BikeNZ and my Member Organisation to have a register of their members as required by section 22 of the Incorporated Societies Act 1908;
 - (b) determining the exact number and categories of the members of my Member Organisation and BikeNZ;
 - (c) determining the membership fee payable by my Member Organisation to BikeNZ;
 - (d) determining the interests and nature of the membership at local, district and national level for the purposes of determining which sponsor and/or stakeholders may be appropriate for my Member Organisation and BikeNZ;
 - (e) enabling my Member Organisation and BikeNZ to communicate with me and other members about my membership (or suspension or termination of it) and matters affecting my Member Organisation and BikeNZ, and for this purpose to supply the information to mail houses;
 - (f) having and maintaining a national database for use by employees and officials of my Member Organisation and BikeNZ, and for use by other members of my Member Organisation and BikeNZ, and in order to maintain this database to enable my Member Organisation to pass the information onto BikeNZ;
 - (g) enabling my Member Organisation and BikeNZ to provide my details to sponsors and stakeholders for the purposes of sponsors or stakeholders contacting members with information about their products and services;
 - (h) enabling my Member Organisation and BikeNZ to comply with any statute, regulation, by-law or other regulatory instrument that requires collection or disclosure of my personal information;
 - (i) any other purpose I agree to in writing.
7. I understand that my personal information will only be used for the purposes listed in paragraph 6 and that my personal information will be held securely, I will have access to my personal information; and my personal information will be corrected upon request.
